GENERAL RULES

Equipment/unit must be operated over a smooth surface such as grass or a hard top surface. The unit may NOT be operated on rough surfaces, such as rocks, bricks, glass or any jagged object(s). Unit must be anchored prior to use and deflated in high winds or gusts. The unit POSITIVELY may not be located within 5 feet of any wall, pole, or fixed object. Children of the same age group and size must play on the unit at the same time. The maximum number of riders in each group that should play on a unit at one time is:

ADDITIONAL RULES

- 1. Always have an adult present to supervise riders.
- 2. Never jump or play on partially inflated unit
- 3. Do not allow riders to play or climb on outside walls, sides or roof of unit.
- 4. Always follow number of riders listed on rental agreement.
- 5. Do not plug and unplug blower repeatedly as it will cause it to burn up.
- 6. Never put a hose or water on unit.
- 7. In case of rain, remove riders and unplug motor and extension cord from wall outlet. After deflated, fold unit on itself to keep play area dry.
- 8. Do not allow riders to hang on or pull netting or columns.
- 9. Do not allow horseplay on unit.
- 10. No Food or Drink allowed on Unit. No Silly String.
- 11. Follow all rules posted on unit and/or blower.
- 12. No Jewelry or sharp objects.

TERMS OF LEASE

The Lessee or using party (Engida, Martha) shall be in charge of operation, and is fully responsible for operation after receiving unit. Lessor is not responsible for any injuries occurring to Lessee or to any persons using the leased property. Lessee further agrees to hold lessor free and harmless against any claims; and further, lessor shall be indemnified for any and all costs incurred due to claim from anyone; including court costs and attorney fees; and other related costs involving the use of this leased equipment. Lessee will provide his or her own liability insurance unless otherwise specified. Lessee is responsible for the replacement value of the new leased object in the event of theft, vandalism, fire or any act that may damage or destroy the leased property.

Some rentals may be paid by check or credit card by previous arrangement. If a check is returned unpaid, the check plus \$25.00 service fee must be paid in cash when notified. If payment is not received at above address, the check will be turned over to an attorney for collection-minimum charge being an additional \$50.00 and court costs.

Failure to observe terms of this agreement, or failure to make payment, or failure to have Bounce Tampa equipment available for return as agreed to, shall make lessee liable to lessor for an additional one day rental fee per day until all equipment is returned, plus any court, legal and/or attorney fees incurred in order to obtain return of these rented products.

RAIN/CANCELLATION/REFUND POLICY: The Lessee has the option to cancel up to the time the equipment is released. Refund or Rain Checks will not be issued in the event the leased equipment is not used for any reason. If the equipment does not work properly it is up to the Lessee, to notify the Lessor to correct.
